#### Dear Jake,

Thank you for taking time in your busy schedule to meet with me this past Thursday. Your job is so important to the lives of your students and their families. Our community is lucky to have such an experienced and compassionate leader at CDM.

I have sent the new school schedule to our membership. I will also announce it at our next HOA meeting a week from this Monday. I do not foresee problems for our community due to the State mandated later start time and ending times.

With the days getting shorter the use of the CDM sports fields with lights will start up again. Our Eastbluff residents have not reported problems to the HOA during the summer. Our Residential Parking Preference program is in effect during the new school year for the two streets closest to the school at the "A" street entrance to Aralia and Arbutus and sections of Aleppo and Alta Vista between these two streets. The city placed "Student Parking Not Permitted" at Eastbluff Dr entrances to our residential streets which continue to be a deterrent to on-street parking on residential street during 7 am to 4 pm school days. With full-time on-premises classes we should expect more vehicles being driven to school as the year progresses. Your efforts to designate appropriate on-campus parking for students and visitors is appreciated.

You asked me to confirm the light and noise limitations for the sports fields. This applies to both the main field with artificial track/turf and the artificial turf field with lights in the center of campus. The following guidelines comply with our joint EIR mitigation guidelines which were approved by our HOA and the NMUSD Trustees.

## **Lights**

The lights on the artificial turf fields are programmed from a central location and will not be turned on outside of approved hours. Board policy limits these times from <u>7:00 AM to 8:00 PM</u> <u>on Mondays through Thursday, and until 9:00 PM on Fridays for a game.</u> Usage of the lights is <u>not permitted on Saturdays and Sundays</u> so that any activities scheduled on these days will of necessity end by dusk.

### Sound

The new facilities do not have access to a sound system. <u>Amplified sound is not approved for</u> <u>outside groups</u>. Occasionally handheld or portable systems will be used in managing events; <u>however</u>, this usage must comply with Board policy which has set 55 decibels at the edge of the <u>closest residential property as the limit</u>. Crowd security and noise supervision will be monitored and enforced by school staff or others specifically designated for that purpose. Additional sound proofing hardware was installed on the bleachers near the football field to help mitigate the noise caused by people walking or stomping their feet.

#### **Attendance**

Attendance at events is limited to the stated capacity for the venue which is set at 664 participants for the football bleachers on the main Track/Field and 200 at the smaller interior field. Additional seating will not be permitted.

Have a successful school year and let's continue to meet at least twice a year to stay in touch and coordinate our efforts to maintain the good neighbor policy and maintain community support for CDM student athletic and academic activities.
